What are we doing well/not so well in Australia?

WELL

- Excellent (overall) public health response
- Transparency of COVID data for residential aged care
- \$440m funding inc for 'surge' staffing & improving infection control +:
 - \$235m COVID-19 'retention bonus' for aged care workers

NOT SO WELL

- Shift to almost exclusive emphasis on clinical care
- Loss of staffing in residential aged care
- Loss of hours in home care
- PPE access still limited in home care

The Aged Care System after COVID 19?

The conditions of work are the conditions of care

Post COVID we need to:

- Address decent work deficits: wages + working time & job security
- Increase 'time to care' to provide for social & emotional wellbeing
- Build in permanent 'surge' capacity in workforce for the 'regular irregularities'
